



We, at **Hotel Bonaparte**, are committed to protecting the Personal Information and privacy of each of our members and current or prospective customers (hereinafter the "**Member**", the "**Customer**" or "**you**"). For the purposes of this Policy, the term "Customer" includes the "Member" and also refers to persons who

visit our website <u>bonaparte.com</u>, sign up for our email communications, participate in any of our programs, in our promotions or contests, request information, correspond or communicate with us.

The application of this Privacy Policy is governed by the requirements of the *Act respecting the protection of personal information in the private sector*, the regulations adopted thereunder and all other applicable legislative provisions and regulations.

Hotel Bonaparte has developed and implemented various directives, procedures and practices for the effective application of this Policy, including:

- procedures intended to protect Personal Information and ensure compliance with this Policy;
- procedures for receiving and handling requests for information and complaints;
- training provided to employees with respect to the protection of Personal Information;
- appointment of a person in charge of the protection of personal information who is responsible for ensuring compliance with this Policy and the procedures and directives deriving from it.

Hotel Bonaparte generally collects, uses, processes, and retains Personal Information to manage and carry out its activities and its mission, to ensure the provision of goods and services required, to administer its programs, as well as for the following objectives or purposes:

- to process information related to your purchases and requests for services and to process their payments;
- to communicate with you, respond to your questions, requests for advice, comments or complaints;
- to send you communications, offers on our products and services, and our Newsletter;



• to verify the identity of Members and Customers, when required or desirable for transactional purposes so as to reduce fraud or errors in transaction processing.

## Access, verification, correction and deletion of Personal Information in our possession

Insofar as Hotel Bonaparte retains Personal Information about you, you have the right to: (i) verify the Personal Information that Hotel Bonaparte holds about you; (ii) request that your Personal Information be corrected or updated; and (iii) withdraw your consent to the use by Hotel Bonaparte of your Personal Information and have your Personal Information deleted from our records.
